1. Fisher College of Business, The Ohio State University (Exchange)

2. Charpak Master's Scholarship

This scholarship is designed for one to two years, (September - June, 10 months per academic year) of studies in France at the Master's degree level for all streams and fields of study. Students will be given a monthly living allowance of 700 euros, a Tuition fee waiver of up to 5000 euros, assistance to find affordable student accommodation (priority access to CROUS residences, subject to availability), and student visa and Etudes en France fee waiver.

6. Bilateral State Scholarships

Bilateral state scholarships are based on scientific and educational cooperation agreements signed by the governments of two countries. Similar to the foreign partner, the Hungarian side offers scholarships for foreign students, researchers, or lecturers in higher education institutions or in scientific or art institutions. Each foreign partner has a national scholarship office which is responsible for nominating potential outgoing scholars to foreign partner(s), as well as arranging their and the potential incoming foreign applicants' application process. These offices work within or related to the particular ministries of education. In Hungary, the national scholarship office is Tempus Public Foundation, a background organization of the Hungarian Ministry for Innovation and Technology (ITM).
