### **1. Graduate Research Scholarships**

Graduate Research Scholarships are awarded to students based on academic merit. The applications are evaluated based on the applicant's research potential in that work area and his/her performance in the last completed degree. Several other factors like relevant professional experience, specialist medical qualifications, and referred publications may also be taken into consideration. There is a 100% fee remission of up to \$110,000. Approximately 600 scholarships will be awarded.

**Location:** Australia

**Deadline:** 31st December 2021

**Eligibility:** Meet the entry requirements for a graduate research degree or be currently enrolled in a graduate research degree at the University of Melbourne

### **2. Griffith Remarkable Scholarship**

This scholarship rewards exceptional students applying for undergraduate and postgraduate coursework degree programs at Griffith University in Queensland, Australia. This scholarship is applicable for Masters Degree, Bachelor's Degree.

**Location:** Australia

**Deadline:** 3rd December 2021

**Eligibility:**

- Be a citizen of a country other than Australia or New Zealand
- Have a minimum GPA of 5.5 or above on a 7 point scale on equivalent

By selecting outstanding scholars, providing them with financial and non-financial support at one of the world's leading universities, and facilitating community building at and beyond Cambridge, it aims to accomplish this mission.

**Location:** UK

**Deadline:** 2nd December 2021 or 6th January 2022 (depending on course)

**Eligibility:** Students aspiring for a Ph.D./M.Phil.

It will be applicable only for the first semester of study.

**Eligibility:** Students aspiring for a Postgraduate degree in Business/Economics/Law.
