1. Inlaks Shivdasani Foundation research travel grants

The Inlaks Shivdasani Foundation supports innovative research work and has been providing scholarships for more than four decades now. The travel grants assist Indian Ph.D. students in undertaking short-time visits to institutions abroad to collect material, use facilities, and consult experts. This award is only for **Humanities and Social Sciences** related subjects.

Location: Any foreign university Deadline: 15th November 2021, 6.00 PM IST Eligibility: Be a registered Ph.D. candidate at an Indian university for at least two years but not more than three years at the time of the application. 2. MBA Student Scholarship - International

The business school of the University of Queensland is offering a 25% tuition fee waiver for outstanding students who are commencing their MBA studies. The scholarship will entitle the successful applicant to receive a 25% discount on their course tuition fees for a maximum period of 24 months. If the scholarship recipient exceeds the 24-month timeframe they become solely responsible for the full tuition cost of any remaining courses after the date specified in the scholarship offer.

3. Graduate Research Scholarships

Graduate Research Scholarships are awarded to students based on academic merit. The applications are evaluated based on the applicant's research potential in that work area and his/her performance in the last completed degree. Several other factors like relevant professional experience, specialist medical qualifications, and referred publications may also be taken into consideration. There is a 100% fee remission of up to \$110,000. Approximately 600 scholarships will be awarded.

4. Chevening Scholarship

Chevening Scholarships are the UK government's global scholarship program, funded by the Foreign and Commonwealth Office (FCO) and partner organizations. The program offers awards to outstanding scholars with leadership potential from around the world to study for a master's degree in any subject at any UK university. This scholarship is offered to extraordinary Indian students to allow them to pursue a one-year postgraduate program in any UK university in any subject. Only a graduate or a postgraduate who wishes to pursue a master's degree in the UK can apply for the scheme.

Location: UK

Deadline: 2nd November 2021 **Eligibility**:

- Return to your country of citizenship for a minimum of two years after your scholarship has ended.
- Have completed all components of an undergraduate degree that will enable you to gain entry onto a postgraduate program at a UK university by the time you submit your application.
- Have at least two years (equivalent to 2,800 hours) of work experience.
- Apply to three different eligible UK university courses and have received an unconditional offer from one of these choices by 14 July 2022.

5. Gates Cambridge

This scholarship program was started by the Bill and Melinda Gates Foundation. It covers the full cost of studying at Cambridge University and offers other discretionary funding as well. This is available only for postgraduate and Ph.D. students.

Deadline: 2nd December 2021 or 6th January 2022 (depending on course) **Eligibility**: Applying to attain any of the full-time residential courses at the University of Cambridge.

6. CommonWealth Masters Scholarships

Commonwealth Master's Scholarships, funded by the UK Foreign, Commonwealth, and Development Office (FCDO), enable outstanding and motivated students to achieve the knowledge and skills essential for sustainable development and are aimed at those who would not be able to study in the UK otherwise. The scholarship is offered under 6 development themes.

Location: UK Deadline: 1st November 2021 **Eligibility**: By September 2022, hold a first degree of at least upper second class (2:1) honors standard, or a second class degree (2:2) and relevant postgraduate qualification (usually a Master's degree)

7. Open Doors Olympiad 2021-2022

Russian Government Scholarships Announced - Open Doors Olympiad 2021-2022 is open for International Students. The scholarship allows Masters, Ph.D. level program(s) in the field of Computer Science, Biology, Biotechnology, Data Science, Mathematics, Artificial Intelligence, Politics, International Relations, Neuroscience, Psychology, Chemistry, Material Science, Economics, Econometrics, Clinical Medicine, Public Health, Earth Sciences, Education taught at Russia Universities. The competition winners will be able to enroll in a program using a single-window system, choosing any of 500 Russian universities.

Location: Russia **Deadline**: 10th December 2021 **Eligibility**: Participants must have a bachelor's (alternatively a five-year specialist's degree) or complete the required degree program in 2022.
