1. Australia India Research Students Fellowship Program

The Australia India Research Students Fellowship (AIRS Fellowship) program supports emerging researchers from India and Australia to undertake short-term research exchanges. 70 fellowships of up to AUD \$10,000 are available, with 35 awards available to applicants from higher education institutions in each country. The program is run by the Australia India Institute and funded by the Australian Government Department of Education.

Location: Australia

Eligibility: The program is open to eligible research students and post-doctoral scholars (early-

career researchers) across all disciplines.

Deadline: 13th November 2022

2. Chevening Scholarship

Chevening Scholarships are the UK government's global scholarship program, funded by the Foreign and Commonwealth Office (FCO) and partner organizations. The program offers awards to outstanding scholars with leadership potential from around the world to study for a master's degree in any subject at any UK university. This scholarship is offered to extraordinary Indian students to allow them to pursue a one-year postgraduate program in any UK university in any subject. Only a graduate or a postgraduate who wishes to pursue a master's degree in the UK can apply for the scheme.

Location: UK Eligibility:

- 1. Have completed all components of an undergraduate degree that will enable you to gain entry into a postgraduate program at a UK university.
- 2. Have at least two years (equivalent to 2,800 hours) of work experience.

3. MBA Student Scholarship - International

The business school of the University of Queensland is offering a 25% tuition fee waiver for outstanding students who are commencing their MBA studies. The scholarship will entitle the successful applicant to receive a 25% discount on their course tuition fees for a maximum period of 24 months. If the scholarship recipient exceeds the 24-month timeframe they become solely responsible for the full tuition cost of any and all remaining courses after the date specified in the scholarship offer.

4. Graduate Research Scholarships

Graduate Research Scholarships are awarded to students based on academic merit. The applications are evaluated based on the applicant's research potential in that work area and his/her performance in the last completed degree. Several other factors like relevant professional experience, specialist medical qualifications, and referred publications may also be taken into consideration. There is a 100% fee remission of up to \$110,000. Approximately 600 scholarships will be awarded.

Location: Australia

Eligibility: Meet the entry requirements for a graduate research degree at the University of Melbourne, or be currently enrolled in a graduate research degree at the University of

Melbourne.

5. Open Doors Olympiad 2022-2023

Russian Government Scholarships Announced - Open Doors Olympiad 2022-2023 is open for International Students. The scholarship allows Master, Ph.D. level program(s) in the field of Computer Science, Biology, Biotechnology, Data Science, Mathematics, Artificial Intelligence, Politics, International Relations, Neuroscience, Psychology, Chemistry, Material Science, Economics, Econometrics, Clinical Medicine, Public Health, Earth Sciences, Education taught at Russian Universities. The competition winners will be able to enroll in a program using a single-window system, choosing any of 500 Russian universities.

Eligibility: Participants must have a bachelor's (alternatively a five-year specialist's degree) or

complete the required degree program in 2023.

6. Netherlands HAN Scholarships

The scholarship allows a Masters' level program(s) in all fields of subjects taught at HAN University of Applied Sciences. Under the HAN Scholarships, the selected students will be given € 7,500 − € 12,500 towards conducting a master's degree study at HAN University.

Eligibility:

- 1. National of a country outside the EU/EEA.
- 2. Should have an IELTS score of at least 6.5, a TOEFL iBT score of at least 90 or a Cambridge Certificate (CAE or CPE)

7. Griffith Remarkable Scholarship

The scholarship is offered under 6 development themes.

Location: UK

Eligibility:By September 2023, hold a first degree of at least upper second class (2:1) honors standard, or a second-class degree (2:2) and relevant postgraduate qualification (usually a Master's degree)
