The main challenge I look forward to addressing in Afghanistan can be framed as a meaningful contribution pertaining to fair and just urban housing. Afghanistan is shown to have one of the most severe global population growth statistics. In fact, according to the Afghan National Development Strategy, there are over 4 million families in need of housing in Afghanistan. In addition to the knowingly located families, there are an estimated three to four million nomads eligible for housing and land according to Article 13 of the Afghan Constitution. Considering that over 25% of the population lives in urban areas, the housing need in the cities has been categorized as crucial. Apart from the already dense, informal and hazardous living situation within number of new families expected to move into the city is not only gargantuan but also keeps growing at a breakneck pace. The urban population is expected to double within the next 15 years. Urban growth has over the last decade been fueled by returnees, the IDPs and rural-urban migrants in search of improved services, security and employment. This phenomenon is irreversible. I want to be part of accommodating this challenge in the upcoming years. Although Kabul has grown haphazardly and informally, access to affordable housing and basic services has been abysmal at best. Issues such as insufficient national policy and regulations to guide urban development, limited spatial plans, and weak municipal governance to ensure equitable service delivery and effective management have been at the forefront of this challenge. The transformation of the current planning and urban management system will require appropriate skills and experience in the urban sector to address the urban housing challenges. I believe that the MSc. In Urban Planning will allow me to both excel my skillset pertaining to urban development and ameliorate my contribution to the urban housing challenge that Kabul faces. I have worked at the office of CRIDA for the past four years, in an effort to both plan and implement governmental projects that are focusing on providing fair urban housing in Kabul especially Kabul New City (KNC) project which is directly leading by my employer. Upon my return, my first priority would be to concentrate and contribute in the housing policy analysis. One of the major responsibilities of CRIDA as an organization is to provide housing schemes for civil servants, refugees, returnees, IDPs and teachers in Kabul. The planning and implementation is meant to be sustainable, affordable and low cost. I am convinced that the wealth of knowledge gained through the master's program in Urban planning that can be applied in our work. I am well-positioned within CRIDA impact the top-down decision making pertaining to planning and implementing social urban housing projects.
