12. Essay:

KNC Development Challenges: Kabul New City (KNC) was designed to be home for 3.7 million people by 2040. The project is located in Dehsabz-Bankab districts (eastern side of Kabul city) in the total land of 740 km² (CRIDA; report) almost one and half times larger than existing Kabul city (the existing Kabul city was designed for 2 million people and the recent survey shows the existing Kabul city population is about 5.7 million people) (Kabul municipality, 2015). The project was initiated in 2006 and The main goal of this project is to provide home and high-quality living environment with the basic infrastructure and services and bringing economic development and resilience according to international standards for more than 3.7 million people and create more than one million job opportunities and other socio-economic activities. KNC could be an imaginary city which can attract local and international investors to contribute in economic and social development of area. Meanwhile, another main purpose of Kabul New City project is to mitigate and decrease the existing issues and challenges (sufficient basic infrastructure, shortage of drinking water, air pollution, housing crisis, slum development, and many others that are getting worsening day by day) of Kabul metropolitan area. After completion of the master plan of KNC there was not any significant progress on this important national mega project. KNC did not get enough attention and support from all involved stockholders. The reasons that stopped the development progress of KNC are existing of land mafia, lack of professionals to develop policies and planning guidelines, economic instability and public private partnership problems. In this case it is necessary to focus the challenges that the project faced and what impact the project have in the term of economic development and resilience to the capital region. The development of KNC is the main task of the authority that I am working as an urban planner. So, after the completion of KNC master plan still it did not developed. It is a big challenge and a big question that why Kabul new city did not developed when the demand for development caused unplanned development in existing Kabul city? And how much it is important in the term of this rapid urbanization that caused a lot of challenges in existing Kabul city. I think we need new policy and development model of PPP for KNC in order to bring back the KNC to development. The master program in the field of urban planning will teach me analyze problems that stopped the development of the KNC, and analyze the development KNC and its impact on economic development and resilience in capital region, and collect the knowledgeable case studies that how this kind of new cities development in the third world countries took place in order to bring economic development and resilience. In addition, the program will help me that how we can involve all stockholders and propose the initiative policies to the development KNC. After the completion of the program; I am expecting to address the main challenges technically and propose policies and planning guidelines in order to develop KNC and proposing solutions to bring back the Kabul new city to development and decrease the existing challenges in the existing Kabul city.
