1. MoU with **Univ. of Nagaoka University**: Santanu Chattopadhyay, RTC

Resolution: The document is approved. It may be made ready for signatures.

2. MoU with **Nagasaki University**: P.P. Chakrabarti, CSE

Resolution: The document is approved. It may be made ready for signatures.

3. SEA with **Nagasaki University**: P.P. Chakrabarti, CSE

Resolution: The committee recommended that the clause for compliance with laws, rules and regulation of the Immersion Program at IITKGP be referred to. The text may be included as modifications in the document and shared with NU for concurrence.

4. MoU with **TPLC**: TBD, Initiated by TPLC,

Resolution: The committee maintained that IITKGP is not interested at this time, since it involves admission of just 01 student, and also because the committee did not see any significant benefit to IITKGP in signing this MoU.

5. MoU with **Indian Rubber Manufacturers Research Association**: Nikhil Singha, RTC

Resolution: The committee noted that this is not an institutional MoU. Certain modifications have been recommended in the document. The committee further noted that clause 8.2 of the document was not acceptable. It was requested that Prof. NK Singha shared the document with the IITKGP legal cell for vetting, after which it may be shared with IRMRA for their concurrence.

6. MoU with **IMDEA**: Somjeet Biswas, MME

Resolution: The committee reviewed the document and recommended certain modifications in the Financial clause. Dr. Biswas is requested to share the modifications with IMDEA for concurrence.

7. MoU with **HZG**: Somjeet Biswas, MME

Resolution: The committee reviewed the document and recommended certain modifications in section on 'IP-Results-confidentiality-Publication'. The publication clauses are too specific and cannot be included in an institutional MoU. Dr. Biswas is requested to share the modifications with HZG for concurrence.

8. MoU with **Karlsruhe Inst. Of Technology**: Manish Mamtani, GG

Resolution: The latest draft of IITKGP template to be shared with Prof. Mamtani for onward sharing.

9. MoU with **Univ of Turin**: Manish Mamtani, GG

Resolution: The committee recommended several modifications in clauses 3.1 and 5 (Mobility flows); 6 (Financial obligations); and 9 (Dispute Resolution). It was also recommended that all instances of 'Agreement' be changed to 'MoU'. OIR will share a modified version with Prof. Mamtani who can then forward it to UTurin for concurrence.

10. MoU with **Lehigh**: Anandaroop Bhattacharya, ADeanIR

Resolution: Minor changes were suggested in Clause 5 (IP). The modifications may be shared with Lehigh for concurrence.

11. MoU with **NDREL-POSOCO**: AK Pradhan, EE

Resolution: The committee suggested Minor changes in the document. Prof. Pradhan is requested to share the modifications with NDREL-POSOCO. If agreed, the document may be made ready for signatures.

Resolution: The Agreement is approved for signatures.




