Memorandum of Understanding

This Memorandum of Understanding made on this day, the 18th of August, 2010 between the Technology Alumni Association, Bangalore, hereinafter referred to as "TAA-BLR", and the Indian Institute of Technology, Kharagpur, having its office at Kharagpur, West Bengal hereinafter referred to as the "Institute", for the "Outstanding Young Faculty Fellowship Program" at the Institute, witnesses as follows:

1. Name of the Program

The Program will be referred to as "Outstanding Young Faculty Fellowship Program, TAA Bangalore", hereinafter referred to as the Program.

2. Objective of the Program

The main objective of the Program is to encourage faculty at IIT Kharagpur, by rewarding a faculty selected as an "Outstanding Young Faculty".

3. Modus Operandi of the Program

Under the Program, the Institute, through a committee constituted for this purpose, known as the Outstanding Young Faculty Committee, hereinafter referred to as the OYFC, would select a faculty as an "Outstanding Young Faculty", hereinafter referred to as Faculty, on an annual basis. The Faculty thus selected would be eligible for:

- a) A Citation
- b) A Rolling Trophy
- c) An financial incentive to be decided by the OYFC jointly with TAA-BLR on a yearly basis

The Faculty would be identified on a rolling basis at the beginning of every academic year as per a predefined set of criteria to be jointly evolved by the TAA-BLR and the Institute. The Program would be funded by individual alumni members of the TAA – BLR, hereinafter referred to as the Donors.

A faculty should be below the age of 35 years to be eligible under the program. Further, the selected faculty member cannot enjoy the benefits under this program simultaneously with any other program, as decided by the OYFC from time to time, which extends similar benefits to the faculty. If such a case arises, the faculty so selected would be required to give up benefits under one of the programs.

4. Formation of Outstanding Young Faculty Committee

The Institute shall form the Outstanding Young Faculty Committee, which will oversee the functioning of the Program as laid down in various clauses of this Memorandum of Understanding. The OYFC will consist of the following:

Director of the Institute or his nominee	Chairman
Nominee of TAA-BLR	Member
Dean (AA&IR)	Member
Dean (Faculty)	Member
Nominee of the Institute	Member

In addition to above, the OYFC may invite certain other eminent faculty from the Institute, as well as student representatives (such as Vice President, Gymkhana) as invitees to proceedings of the OYFC.

5. Role of the OYFC

The OYFC shall meet at least once a year to plan, review and coordinate the activities of the Program. The role of the OYFC will, *inter alia*, include:

- a) Formulating rules for the selection of the Faculty
- b) Accepting nominations to the Outstanding Young Faculty fellowship
- c) Collecting necessary information to evaluate the candidature of various faculty nominated for the award
- d) Evaluating and selecting the Outstanding Young Faculty on a yearly basis
- e) Receiving the payments from the Donors and disbursing the incentive to the Faculty.
- f) Donors will directly draw a cheque favoring "IIT Kharagpur" or any other account provided by the Institute so as to avail 80G or appropriate tax benefits to the Donors.
- g) Ensuring the Donors get necessary receipts, in a timely manner, for the donations made towards the Program.
- h) Furnishing an annual statement of receipts from the Donors to the Program and disbursement to the Faculty

6. Role of the TAA-BLR

TAA-BLR's role would, *inter alia*, include :

- a) Spreading awareness about the Program amongst its member alumni
- b) Identifying Donors who would donate the requisite amounts for the Program
- c) Taking commitment from the Donors and keeping record of the same so as to facilitate smooth flow of funds for the Program
- d) Identifying replacement Donors if the committed Donors for the year are not in a position to donate for any reason
- e) Planning the donations in such a way as to cause a sum, which will be not less than one year's outgo for the Program, to be deposited by the Donors into the Institute's account at the beginning of the academic year
- f) Collecting the cheques from the Donors in the name of the Institute for the Program and facilitating deposit of the cheques into the nominated bank account of the Institute
- g) Nominating a representative to the OYFC, who will liaise with the Institute on behalf of the TAA-BLR and the Donors. The TAA-BLR nominee will be appointed every two years
- h) Coordinating with the Institute on behalf of the Donors to ensure the Donors get receipts and tax exemption certificates for the donations made for the Program, as eligible.

7. Tenure

The Faculty would be identified on a rolling basis every year as per a predefined set of criteria to be jointly evolved by the TAA-BLR and the Institute. The tenure of the Program will initially be a period of five years, which may further be extended from time to time.

8. Financial Incentive

For the first year (2010-2011), the financial incentive shall be a sum of Rs. 15,000 per month (Rupees Fifteen Thousand only per month). Thereafter, the financial incentive shall be determined by the OYFC from time to time, jointly with the TAA-BLR.

9. Review of MoU

Notwithstanding anything contained herein, it is hereby agreed by and between the parties that the terms and conditions of this Memorandum of Understanding can be reviewed and, if necessary be modified, and/or extended by mutual agreement between TAA-BLR and the Institute.

- e) Planning the donations in such a way as to cause a sum, which will be not less than one year's outgo for the Program, to be deposited by the Donors into the Institute's account at the beginning of the academic year
- f) Collecting the cheques from the Donors in the name of the Institute for the Program and facilitating deposit of the cheques into the nominated bank account of the Institute
- g) Nominating a representative to the OYFC, who will liaise with the Institute on behalf of the TAA-BLR and the Donors. The TAA-BLR nominee will be appointed every two years
- h) Coordinating with the Institute on behalf of the Donors to ensure the Donors get receipts and tax exemption certificates for the donations made for the Program, as eligible.

7. Tenure

The Faculty would be identified on a rolling basis every year as per a predefined set of criteria to be jointly evolved by the TAA-BLR and the Institute. The tenure of the Program will initially be a period of five years, which may further be extended from time to time.

8. Financial Incentive

For the first year (2010-2011), the financial incentive shall be a sum of Rs. 15,000 per month (Rupees Fifteen Thousand only per month). Thereafter, the financial incentive shall be determined by the OYFC from time to time, jointly with the TAA-BLR.

9. Review of MoU



This Memorandum of Understanding made on this day, the 18th of August, 2010 between the Technology Alumni Association, Bangalore, hereinafter referred to as "TAA-BLR", and the Indian Institute of Technology, Kharagpur, having its office at Kharagpur, West Bengal hereinafter referred to as the "Institute", for the "Outstanding Young Faculty Fellowship Program" at the Institute, witnesses as follows:

1. Name of the Program

The Program will be referred to as "Outstanding Young Faculty Fellowship Program, TAA Bangalore", hereinafter referred to as the Program.

2. Objective of the Program

The main objective of the Program is to encourage faculty at IIT Kharagpur, by rewarding a faculty selected as an "Outstanding Young Faculty".

3. Modus Operandi of the Program

Under the Program, the Institute, through a committee constituted for this purpose, known as the Outstanding Young Faculty Committee, hereinafter referred to as the OYFC, would select a faculty as an "Outstanding Young Faculty", hereinafter referred to as Faculty, on an annual basis. The Faculty thus selected would be eligible for:

- a) A Citation
- b) A Rolling Trophy
- c) An financial incentive to be decided by the OYFC jointly with TAA-BLR on a yearly basis

The Faculty would be identified on a rolling basis at the beginning of every academic year as per a predefined set of criteria to be jointly evolved by the TAA-BLR and the Institute. The Program would be funded by individual alumni members of the TAA – BLR, hereinafter referred to as the Donors.

A faculty should be below the age of 35 years to be eligible under the program. Further, the selected faculty member cannot enjoy the benefits under this program simultaneously with any other program, as decided by the OYFC from time to time, which extends similar benefits to the faculty. If such a case arises, the faculty so selected would be required to give up benefits under one of the programs.

4. Formation of Outstanding Young Faculty Committee

The Institute shall form the Outstanding Young Faculty Committee, which will oversee the functioning of the Program as laid down in various clauses of this Memorandum of Understanding. The OYFC will consist of the following:

Director of the Institute or his nominee	Chairman
Nominee of TAA BLR	Member
Dean (AA&IR)	Member
Dean (Faculty)	Member
Nominee of the Institute	Member

In addition to above, the OYFC may invite certain other eminent faculty from the Institute, as well as student representatives (such as Vice President, Gymkhana) as invitees to proceedings of the OYFC.

5. Role of the OYFC

The OYFC shall meet at least once a year to plan, review and coordinate the activities of the Program. The role of the OYFC will, inter alia, include:

- a) Formulating rules for the selection of the Faculty
- b) Accepting nominations to the Outstanding Young Faculty fellowship
- c) Collecting necessary information to evaluate the candidature of various faculty nominated for the award
- d) Evaluating and selecting the Outstanding Young Faculty on a yearly basis
Receiving the payments from the Donors and disbursing the incentive to the Faculty.
- e) Donors will directly draw a cheque favoring "IIT Kharagpur" or any other account provided by the Institute so as to avail 80G or appropriate tax benefits to the Donors.
- f) Ensuring the Donors get necessary receipts, in a timely manner, for the donations made towards the Program.
- g) Furnishing an annual statement of receipts from the Donors to the Program and disbursement to the Faculty

6. Role of the TAA-BLR

TAA-BLR's role would, inter alia, include :

- a) Spreading awareness about the Program amongst its member alumni
- b) Identifying Donors who would donate the requisite amounts for the Program
- c) Taking commitment from the Donors and keeping record of the same so as to facilitate smooth flow of funds for the Program
- d) Identifying replacement Donors if the committed Donors for the year are not in a position to donate for any reason
- e) Planning the donations in such a way as to cause a sum, which will be not less than one year's outgo for the Program, to be deposited by the Donors into the Institute's account at the beginning of the academic year
- f) Collecting the cheques from the Donors in the name of the Institute for the Program and facilitating deposit of the cheques into the nominated bank account of the Institute
