

AGREEMENT

BETWEEN

The University of Pavia fisc.code 800072700186, represented by the Rector Prof. Angiolino Stella, born on 13 june 1937, in Molino de' Torti (AL), resident for his role, in Pavia, Strada Nuova 65

AND

The Indian Institute of Technology Kharagpur, represented by Prof. S K Dube, Director

IN VIEW OF

on 14th February 2005, the Italian Ministry of Education, University and Research and the Indian Ministry for Science and Technology signed a Memorandum of Understanding, in which the Italian Government has undertaken to provide financial support for 100 research scholarships, in favour of Indian researchers working in common areas of interest;

on the basis of the above mentioned Memorandum the M.I.U.R. (Italian Ministry of Education), has awarded, for the financial year 2005, the total amount of € 1.500.000 in order to support N.100 scholarships in favour of young Indian researchers;

the M.I.U.R., with communication N. 1987 – 21/11/05, has granted the University of Pavia, N.4 annual scholarships in favour of Indian researchers with an amount of € 15,000.00 each one.

THE FOLLOWING AGREEMENT IS REACHED AND SIGNED

Art.1 The University of Pavia and the Indian Institute of Technology Kharagpur assure that the procedures of scholars' selection in order to award the above mentioned scholarships will take place on the basis of meritocracy, equity, transparency and without gender discrimination.

Art.2 Intellectual Property:

Each institution will adhere to its own IP policy and the intellectual laws of the respective nations. Intellectual property developed during the visit of exchange students/faculty will be governed by the rules of the host institute unless otherwise specified by an alternate agreement. The two institutions shall jointly own the results, IP generated and any derivatives thereof from clearly defined collaborative studies/projects.

Whenever one institution receives any information from the other, necessary steps will be taken to protect the intellectual property received under a clearly defined nondisclosure agreement.

Art.3 The University of Pavia assure that the scholarships will be free of charge by university tuitions and fees.

Art.4 The University of Pavia will offer to the selected researchers accommodation benefits and free meals in the University Residences.

Art.5 The University of Pavia will offer to the selected researchers free intensive Italian language courses (basic), organized by the University Language Centre, facilities for self-learning and tutoring included.

Art.6 All the scholarships approved by the M.I.U.R. are included in the Research Area Nano-Science and Nano-Technology.

Art.7 This Agreement will be in force until the end of the administrative procedures of the above mentioned scholarships and, in any case, until the conclusion of the research period of the selected scholars.
