MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding (hereafter MOU) between the Indian Institute of Technology Kharagpur (IIT Kharagpur) and the Norwegian University of Science and Technology (NTNU) constitutes a framework for cooperation between the two parties.

Article 1

The MOU's objective is to facilitate further cooperation in research and education. This MOU is a statement of intent to foster genuine and mutually beneficial collaboration.

Article 2

This MOU shall remain in force for an initial period of five (5) years from the date of the last signature. Thereafter it shall be automatically renewed for successive five-year periods, unless either University terminates this Agreement by giving six month written notice to the other party. Any amendments to the MOU are subject to approval in writing by both parties.

In case of disagreements between the two parties, this MOU can be cancelled by both parties by giving six month written notice prior to the date of cancellation. However, specific commitments made prior to such intimation shall be honoured by both the partners including ensuring that any student at that time participating in the Programme is able to complete the term of the assignment and be assessed for it.

Article 3

The two parties shall seek to promote:

1. Mobility of graduate and/or undergraduate students
2. Mobility of faculty and/or staff
3. Joint research activities and publications
4. Participation in seminars and academic meetings
5. Exchange of academic materials and academic publications;
6. Special short-term academic programs

Article 4

The parties may sign an Intellectual Property Rights (IPR) document in order to secure rights when it comes to research results and publications.

Article 5

Participating staff and students involved in any activities under this MOU must adhere to the law of the host countries and rules and regulations of the host institutions.
