# MEMORANDUM OF UNDERSTANDING

Between

**INDIAN INSTITUTE OF TECHNOLOGY KHARAGPUR**

And

**CHOSUN UNIVERSITY, REPUBLIC OF KOREA**

Indian Institute of Technology Kharagpur (hereafter referred to as "IITKGP") and Chosun University of the Republic of Korea enter into agreement under the following terms for the purpose of furthering educational and research exchange and thus deepening the friendship between both the Institutes.

1. Both the Institutes agree to cooperate in order to expand opportunities for further development of research, and other academic activities. The cooperation will include the following activities.
  - (i) Exchange of teaching staff and researchers
  - (ii) Exchange of students (including graduate students);
  - (iii) Joint research, academic seminars
  - (iv) Other exchange activities to which both the Institutes agree
2. The details of exchange mentioned above are determined by mutual agreement between both the Institutes on case-by-case basis.
3. This agreement will come into effect upon signing by the representatives of both the Institutes. The term of validity is five years from the date of the later signature and can be extended through a joint agreement by the both Institutes. This agreement may be terminated, even within the term of validity by either or both the Institutes upon submission of a request for its cancellation six months in advance.
4. Participation and Coordination : The partnership shall initially be between the following:

**For IIT-KGP :**

Department of Aerospace Engineering in the following specializations :

- (i) Aerospace Structures
- (ii) Aerospace Propulsion
- (iii) Aircraft Design
- (iv) Aerospace control dynamics
- (v) Computational fluid dynamics

**For Chosun University, Republic of Korea :**

- (i) Department of Aerospace Engineering
- (ii) Department of Naval Architecture

Prof. Changduk Kong of Department of Aerospace Engineering will be the Coordinator for Chosun University, Republic of Korea and Prof. P. K. Datta of Department of Aerospace Engineering, Indian Institute of Technology, Kharagpur will be the Coordinator for IIT-KGP.


The participants and Coordinators may change from time to time as decided by competent authority of the respective institutions.

## 5. Financing

The two institutions will develop a funding pool from various sources to carry out this partnership. They will not only try to arrange some funding from their own resources, but also vigorously approach their own governments, international funding agencies and industries. Special attention will be given to obtain funded projects from industry to support this collaboration.

Both institutes will provide tuition and service fee waivers to the exchange students. The host institute will arrange accommodation to exchange students and faculty if exchange students and faculty want. However exchange students and faculty pay the accommodation charges at their own expenses.

6. This Memorandum of Understanding must be in conformance with prevailing rules and regulations of the two Institutions and countries and includes IPR rules.
7. Two sets of the English versions of the Memorandum of Understanding will be made and all will be treated as original and each Institute will keep one set of the versions.
