BETWEEN

DEAKIN UNIVERSITY, a body politic and corporate established pursuant to the *Deakin University Act 1974* of Geelong 3217 in the State of Victoria, Australia ('Deakin')

AND

INDIAN INSTITUTE OF TECHNOLOGY, KHARAGPUR, of Kharagpur, India 721302
(‘IIT Kharagpur’)

This Memorandum of Understanding records the intentions of Deakin and IIT Kharagpur to work in a spirit of cooperation to establish academic links between the two institutions, with particular emphasis on collaborative research, collaborative development of teaching materials and learning resources, and staff and student exchanges.

THE PARTIES AGREE:

1 Areas of cooperation

The parties will discuss avenues for cooperation in the following areas:

- 1.1 academic staff exchange to promote collaborative research;
- 1.2 development and delivery of professional development programs for executives in technology-based enterprises of India, Australia and other countries;
- 1.3 design and development of distance learning undergraduate programs;
- 1.4 development of multi-media teaching materials;
- 1.5 student exchange;
- 1.6 other areas of information exchange for mutual benefit.

2 Initial focus of cooperation

In the first instance, discussion will focus on specific possibilities for cooperation in the following areas:

- 2.1 development of computer-based learning resources, for example, virtual laboratory experiments;
- 2.2 development of courses in construction management; technology management, environmental management and clean production strategies;
- 2.3 applications for funding for cross-country research.


