
**Sub: Request for approval for signing the MoU with African-Asian Rural Development Organization (AARDO)**





# **MEMORANDUM OF UNDERSTANDING**



## MEMORANDUM OF UNDERSTANDING



This **MEMORANDUM OF UNDERSTANDING (MOU)** entered into on the \_\_\_\_\_ Day of \_\_\_\_\_ 2022 between:

**The AFRICAN-ASIAN RURAL DEVELOPMENT ORGANIZATION** (hereinafter referred to as “**AARDO**”), a rural centric inter-governmental autonomous organization located at 2, State Guest Houses Complex, Chanakyapuri, New Delhi 110 021, India and represented by the **Secretary General, AARDO** and shall include its lawful representatives and permitted assignees;

**AND**

**THE INDIAN INSTITUTE OF TECHNOLOGY KHARAGPUR** (hereinafter referred to as “**IITKGP**”), an academic and research institute constituted by Government of India located at Kharagpur- 721 302, West Bengal, India and represented by the **Director** and shall include its lawful representatives and permitted assignees;

**AARDO and IITKGP shall hereinafter referred to singularly as “the Party” and collectively as “the Parties”.**

### **WHEREAS**

African Asian Rural Development Organization, New Delhi is mandated to develop understanding among members for better appreciation of each other's problems and to collectively explore, opportunities for coordination of efforts for the welfare and eradication of thirst, hunger, illiteracy, disease and poverty amongst rural people in the African-Asian region. The Organization comprises thirty three (33) members, which include thirty one (31) countries namely, Burkina Faso, Egypt, Ethiopia, Gambia, Ghana, Kenya, Liberia, Libya, Malawi, Mauritius, Morocco, Namibia, Nigeria, Sierra Leone, Sudan, Tunisia and Zambia from Africa, and Bangladesh, R.O. China (Taiwan), India, Iraq, Jordan, R.O. Korea, Lebanon, Malaysia, Oman, Palestine, Pakistan, Sri Lanka, Syria and Yemen from Asia, as the full members, and Korea Rural Community Corporation (KRC), R.O. Korea and The Agricultural Bank of Sudan (ABS), Sudan as Associate Members.

AARDO is devoted to developing understanding among members for better appreciation of others' problems and to explore collectively, opportunities for coordination and efforts for promoting welfare and eradication of thirst, hunger, illiteracy, disease and poverty among rural people.



Indian Institute of Technology Kharagpur (IITKGP) is a premier institute of the country established in 1951 to train engineers and researchers. It is the first IIT which was created by the Government of India and has been recognized as an institute of national importance. It offers bachelors, masters and doctoral degrees in various areas under different departments, centres, and schools. The Agricultural and Food Engineering (AgFE) Department was established in 1952, as the Agricultural Engineering Department on the recommendation of the Dhar Committee appointed by the Board of Governors, IIT Kharagpur in 1950. Subsequently, on the up-gradation of its academic programme, the department was renamed as the Agricultural and Food Engineering Department in 1994. It has been regularly working on creating technology-based solutions for sustainable development.

Among the 23 IITs, IIT Kharagpur has the sole distinction of having an Agricultural and Food Engineering Department and Centre for Rural Development, Innovation and Sustainable Technologies (CRDIST). Ever since its establishment, the department has pioneered Agricultural Engineering education and research in the country. Keeping pace with the technological and agricultural developments, the department has continuously upgraded its academic programs. Today it offers a 4-year B. Tech. (Hons) course in Agricultural and Food Engineering, six Joint M.Tech. - Ph.D. programmes in different specializations of agricultural engineering and sciences, and 5-year integrated M. Tech. programmes in all four engineering specializations. Also, the department offers M.S. (by research) and Ph. D. programmes in all areas of specialization.

Agricultural and Food Engineering (AgFE) is the largest department of IIT Kharagpur. Over the last seven decades, the department has grown its expertise and competence and produced pioneer research, development and education in the field of agricultural engineering in India. The Department has several state-of-the-art laboratories, field research facilities and an adopted village for transferring the developed technologies. The Department is adequately experienced in creation and dissemination of appropriate rural technologies through its recent flagship initiatives. Rural Technology Action Group (RuTAG) and Design and Innovation Centre (DIC) are such platforms that have successfully translated research ideas into meaningful prototypes that address agricultural and rural issues.

The AgFE Department has been developing technologies and facilities that are directly or indirectly helping the local rural community. These technologies are demonstrated and transferred among the interested rural community.

**CONSIDERING** the mutual interest in the field of agriculture and rural development in AARDO Member Countries, both two Organizations agree to cooperate and collaborate with each other with a view to achieving their common objectives, in particular with regard to address the challenges through technological innovations, solutions and interventions and capacity enhancement to benefit and strengthen rural communities.

**HAVING IN MIND** the fact that both the Organizations have the common mandate,

**DESIROUS** of establishing cordial ties, strengthening cooperation and initiating collaboration between the two Organizations for the benefit of rural communities, farmers, entrepreneurs, executives, functionaries and policy makers of the Member Countries in Africa and Asia.



**CONSIDERING** their common interest in addressing the challenges facing the Member Countries through cooperation and collaboration in the areas of agriculture and rural development.

**RECOGNIZING** the need for enhancing the self-reliance, economic resilience and social well-being of the people through sustainable livelihoods, quality of life, reduced drudgery through innovative machine and process development, and creation of safe and healthy environment in the Member Countries;

**CONVINCED** that the development and strengthening of their cooperation would be of mutual benefit to bring about better coordination and efficient implementation of respective resolutions.

**AARDO and IITKGP** hereby agree to cooperate in capacity building, knowledge and dissemination, and transfer of appropriate/adaptable & affordable innovative solutions/technologies for agricultural and rural development in the Member Countries in accordance with the below terms and conditions of this Agreement.

Now, therefore, for good and valuable consideration, both the parties hereby agree into the following:

## Article I

### 1. Objectives of Cooperation:

The objective of cooperation of this Agreement shall be-

- 1.1. Collaboration for knowledge partnership through exchange of knowledge & experiences, capacity enhancement and development of technological interventions in the fields of agricultural and rural development and sharing/transferring of technology.
- 1.2. To act as a forum to facilitate the exchange of views and ideas for continuing dialogues on innovative and suitable models of Cooperation for agricultural and rural development.

## Article II

### 2. Areas of Cooperation:

- 2.1. Both the Parties shall cooperate with each other through the mutually decided areas/technologies to realize the common interests in the field of agriculture and rural development, and other related domains.



Technological interventions in the areas of fisheries, energy, livestock, aquaculture, hydro/aqua-ponics, transportation, sustainable agriculture, crop diversification with industrial crops, organic farming, rural settlement, farm machinery development, ergonomics, agricultural automation, smart tools and machines, smart irrigation, low-cost greenhouse, non-invasive soil health monitoring and testing, nano-fertilizers, biofuel and bioenergy, zero-waste process/product development, soil-to-soil technology, medicinally important plants, food-fortification to address malnutrition, food processing & value-addition, agribusiness development, automation and food process industry, water & waste management, diffusion and transfer models/channels for effective adoption of innovative, affordable and appropriate techniques etc.

2.2. For the purpose of implementing the co-operation in respect of any stated in Article 2.1. above, the Parties shall enter into a legally binding and definitive agreement subject to the terms and conditions as mutually agreed upon by the Parties including clauses on "confidentiality", "suspension", "protection of intellectual property rights" and "settlement of disputes" before entering into any specific programme.

### Article III

### **3. Instruments and Form of Cooperation:**

Both the Parties agree to consider and use the following instruments:

- (a) Organization of Human Resource Development, Capacity Enhancement, Education and Training programmes.
- (b) Organization of international, regional and On-The-Spot (OTS) /in country training programmes/workshops to strengthen the institutional capacity of the Member Countries in sustainable agriculture and rural development.
- (c) Organization of Workshops/Seminars/Conferences/Roundtables for various levels of participation and different levels of coverage such as International/Regional/National levels.
- (d) Joint exploration and implementation of Technology-based Development PILOT Projects by utilizing each other's human, technical and financial resources, subject to modalities, towards achieving common goals;
- (e) Conducting research for action-research studies of specific or of common interest;
- (f) Exchange of subject experts/specialists for sharing of knowledge, expertise and experience.
- (g) Exchange of scholars/students/volunteers to assist in adoption of technology solutions and implementation of joint tech-based development pilot projects, training of grassroots functionaries/beneficiaries, and learning from varied experiences;
- (h) Exchange programmes and internships for UG/PG students, faculty, staff and researchers with universities and Institutes in the Member Countries.
- (i) Technical support in project formulations and consultancy in the area of policy formulation;



- (j) Strengthening Institutional networking for enhanced collaboration in the fields of agriculture and rural development;
- (k) Utilization of expertise from IITKGP's Rajiv Gandhi School of Intellectual Property Law for inputs on policy documents, imparting training, consultancies; and appropriate techno-legal expertise.
- (l) Any other form agreed to by the Parties.

#### Article IV

#### **4. Implementation:**

AARDO and IITKGP shall, subject to mutual agreement on case-to-case basis, undertake joint activities and cooperation in the implementation of specific programmes/projects in the field of agriculture and rural development.

#### Article V

#### **5. Financial Arrangement:**

- 5.1. This Memorandum of Understanding shall not automatically give rise to any financial obligation by one Party to other, unless otherwise agreed upon by both the Parties in writing.
- 5.2. Each party shall bear its own cost and expenses in relation to this Memorandum of Understanding unless otherwise agreed between the Parties in writing.
- 5.3. The Parties shall discuss the sharing of costs before each activity/engagement.

#### Article VI

#### **6. Duration & Termination of the Agreement:**

- 6.1. This Memorandum of Understanding will come into effect on the date of signing and will remain in effect for a period of five (5) years.
- 6.2. This Memorandum of Understanding may be terminated by either Party giving written notice to the other at least six (6) months prior to the proposed date of termination.



## Article VII

### **7. Intellectual Property Rights (IPR):**

- 7.1. The protection of intellectual property rights shall be enforced in conformity with the respective national legislations and law prevailing in the concerned countries, rules and regulations of both the Parties.
- 7.2. Notwithstanding anything in Article 7.1 above, the intellectual property rights in respect of any technological development and any products and services development carried out:
- (a) jointly by the Parties or research results obtained through the joint activity/effort of the parties will jointly owned by the Parties in accordance with the terms to be mutually agreed upon, and;
  - (b) solely and separately by the Party or the research results obtained through the sole and separate efforts of the Party will solely be owned by the Party concerned.

## Article VIII

### **8. Settlement of Disputes:**

Any difference or dispute between the Parties concerning the interpretation and/or implementation and/or application of any of the provisions of this Memorandum of Understanding shall be settled amicably through mutual consultation and/or negotiations between the Parties **at Kolkata**.

## Article IX

### **9. Amendment:**

Further the term of the MoU may be amended with the approval of both Parties, by means or exchange of letters.

# **Annexure 1**

Scholarship for  
M.S (Research) Programme



## Scholarships for MS (Research) Programme

WHEREAS AARDO and IITKGP (hereinafter referred to as ("both parties")) are committed to work towards innovative and sustainable development for agricultural/rural communities and have joined hands to make concerted efforts through participation by young eligible students/officers from AARDO member countries in the "MS (Research) Programme" (hereinafter referred to a "programme"), being organized at IITKGP to build-up their capacity and nurture them as global leaders to play a pivotal role in modern agriculture and rural development for agribusiness development, combating malnutrition, and overall sustainable development for the betterment of the rural communities.

WHEREAS both parties have felt the need of AARDO member countries for building up capacities of dynamic young eligible students/officers and nurturing them as global leaders to play a pivotal role in combating poverty and working for the betterment of the under-privileged through the Programme at IITKGP.

THEREFORE both parties have agreed to cement the collaborative approach for the participation of AARDO sponsored candidates to the MS (Research) Programme at IITKGP for the minimum of next five (05) years for the larger benefit of AARDO member countries. However, the programme continuation will be determined annually based on the performance of the programme and budgetary considerations.

### SECTION I "DEFINITIONS"

This Annexure shall be known as the "Scholarships for MS (Research) programme" between IITKGP and AARDO for participation in the Programme by eligible students/officers from African-Asian member countries.

### SECTION II 'ORGAINZATION OF THE PROGRAMME"

The Programme shall be open for participation by AARDO member countries at IIT Kharagpur every year with effect from the academic session starting from July 2022.

The duration of the Programme shall be as per IITKGP Senate Rule (minimum 2 years and maximum 5 years).



AARDO may nominate candidates to IITKGP and selection of up to 20 suitable students/officers for the Programme shall be made as per selection criteria of IITKGP under intimation at AARDO. The number of selected candidates may exceed 20 on the mutual agreement of the six specializations of the Department of Agricultural and Food Engineering (AgFE) and Centre for Rural Development and Innovative Sustainable Technology (CRDIST) of IITKGP and AARDO. All applicants to the MS (Research) Programme will follow the same norms for selection and academic requirements as per rules and regulations Instituted by IITKGP.

### SECTION III "EVALUATION OF THE PROGRAMME"

Both parties shall undertake separate evaluation on the conclusion of the Programme and share their findings with each other for further improvement.

Both parties shall make their best efforts to raise awareness among the member countries about the usefulness and achievements of this joint programme.

### SECTION IV "LIABILITIES OF AARDO"

AARDO may nominate candidates every year to the Programme organized by IITKGP.

AARDO shall request its member countries to forward particulars of suitable candidates who meet the prescribed eligibility criteria for admission directly online to IITKGP under intimation to AARDO.

AARDO shall follow up the nominations with IITKGP for their evaluation and subsequent acceptance.

AARDO/Member Country shall provide both ways air tickets to its selected participants to travel to the nearest airport (Kolkata) in India and back.

### SECTION V "LIABILITIES OF IITKGP"

IITKGP shall arrange to intimate AARDO Secretariat about the schedule of the Programme preferably six (06) months in advance enabling AARDO to invite/arrange suitable nominations from its member countries. For the first year the Parties will discuss and set out the schedule on a mutually agreeable basis.

IITKGP shall intimate the AARDO Secretariat the changes/amendments, if any, in the timetable of its Programme, preferably three (03) months prior to the commencement of the Programme enabling AARDO to make relevant arrangements accordingly.



IITKGP shall receive nominations of the candidates in duly filled-in prescribed proforma from AARDO as per schedule. After due consideration, IITKGP shall, in due time notify AARDO of the accepted candidates, IITKGP will advise and assist students/officers in the visa process.

The fellowship granted to AARDO participants of the Programme by IITKGP will waive the International student tuition fee, one-time admission charges, hostel charges and provide them with a fellowship equivalent to the Master students' stipend given to domestic students/officers as a living allowance up to two years.

However, other expenses incurred during the travel and during the programme at IITKGP shall be borne by the students/officers and/or his/her respective country government.

The student must attend classes in IITKGP in-person/online to receive the fellowship.

Students/officers would be required to open an Indian bank account on arrival at IITKGP and intimate the details to receive the fellowship.

Students/officers shall cover the costs of course material, food expenses, local transportation, medical insurance and monthly living expenses for the duration of the program at IITKGP. Students/officers will cover all costs including tuition for an extension beyond two years. This is also subject to the student complying with the rules and regulations of IITKGP and all applicable laws including in relation to the visa requirements.

The students/officers must satisfactorily complete the program in adherence to the rules and regulations stipulated by IITKGP to obtain the degree

6. Renewal MoU with **National Tsing Hua University (NTHU), Taiwan**: Prof. Dipanwita Roy Chowdhury, CSE


**Resolution:** The MoU and Student Exchange Agreement are approved for signatures.







