**Subject: Request for Approval to Permit Foreign Students' Participation in
CDC Placement**

Thanks to many programmes instituted by Government of India in the last few years a number of students from neighbouring countries apply for admission to various M.Tech programmes in different IITs. However, while others IITs facilitate the international students admitted to such programmes in getting suitable jobs after the completion of their studies by allowing them to participate in campus interviews along with other Indian students, there is no such facility available in IIT Kharagpur. This discrimination puts our Institute in a disadvantageous position during selection of place of study by a foreign student. Consequently many good students seek admission to other IITs where they get opportunity to appear for job interviews at the end their study.

In order to increase the strength of international students in the Institute, an essential requirement for improving its ranking, the facility to appear for campus recruitment may kindly be extended to those students who possess requisite documents for the same. It may be noted in this regard that citizens of many countries may not require any additional document for getting a job in India.

Further, the above facility to the international students, if provided, will strengthen our internationalization drive towards attracting more students who are willing to pursue higher education in India with self-funding.

You are therefore requested to permit the international students to avail the placement facility at par with other Indian students.

This is placed for your kind consideration and approval.
