The sanction has been accorded under powers vested in this Ministry in concurrence with the Integrated Finance Division of this Ministry vide their Dy.No.178/2023-24 dated 30.05.2023 certified by IFD's Section vide their Dy.No. 127/2023/IF-1 dated 30.05.2023. This is to certify that the present sanction /expenditure is covered under the QEP/MEP for 1st Quarter for the month of **May, 2023** and the Integrated Finance Division(IFD) has approved the expenditure during the current quarter.

7. The Grant is subject to adjustment on the basis of audited statement of accounts of the Institute. The accounts of all grantee Institutions or Organizations shall be open to inspection by the sanctioning authority and audit, both by the Comptroller and Auditor General of India under the provision of CAG (DPC) Act, 1971 and Internal Audit by the Principal Accounts Office of the Ministry / Department whenever the Institute or Organizations is called upon to do so. This grant may be utilized for development of necessary infrastructure.

8. IIT Delhi (CNA) shall ensure that the total number of students, their eligibility and also the quantum of funds being released are strictly as per the schematic norms and the amounts be re-verified to avoid duplicate payments or genuine cases are missed out.

9. The requirements of production of Utilisation Certificate in respect of the grants being sanctioned by the Government of India should be fulfilled to the satisfaction of the Government. **The Institute shall furnish Utilization Certificate (UC) immediately after the closing of financial year 2023-24.** No Previous Utilization Certificate (UC) is due / pending in respect of this Institute in any scheme related to it.


10. In future, grants will be released to the Institutes only after the Institute has satisfied the Ministry that adequate provision for representation of SC / ST has been made in actual practice in filling up vacancies reserved for SC / ST candidates every year.

11. The Institute shall fully implement the Official Language Policy of the Union Government i.e. the Institute shall comply with the Official Language Act, 1963 and Official Language (use of the official purpose of the Union) Rules, 1976, etc.

12. The Grantee is situated under the jurisdiction of the concern Accountant General Audit in respective Region/State under the office of Director General of Audit, Central, New Delhi.
