Memorandum of Agreement

for

Anand Deshpande International Travel Grant for Students

This Memorandum of Understanding ("MoU") by and between IIT Kharagpur (the "Institute") and Mr. Anand Deshpande (1984/B Tech/CS/Patel) (the "Donor"), is made effective as of

1st June of 2022, 2022.

This MoU is being signed to set up the Anand Deshpande International Travel Grant for Students with the kind donation received from Mr. Anand Deshpande.

A. Objective

To institute and provide support for the 'Anand Deshpande International Travel Grant for Students' of an amount of maximum INR 3,00,000 (Rupees Three Lakh Only), to a UG/PG/MS/PhD female student from the Department of Computer Science and Engineering, subject to the availability of the fund for presenting a paper in any international conference.

B. Background

Dr. Anand Deshpande is the Founder, Chairman and Managing Director of Persistent Systems since its inception and is responsible for the overall leadership, strategy and management of the Company. Anand has been the driving force in growing Persistent Systems from its inception in 1990, to the publicly-traded global Company of today.

Prior to founding Persistent Systems, Anand began his professional career at Hewlett-Packard Laboratories in Palo Alto, California, where he worked as Member of Technical Staff from May 1989 to October 1990. Anand has served numerous positions at various professional and non-profit organizations viz. NASSCOM's Executive Council, ACM (Association for Computing Machinery) India, where he was the first President, SEAP (Software Exporters' Association of Pune), Pune Chapter of CSI (Computer Society of India), CII's Pune Zonal Council, Trustee in the Computer History Museum, Dean's Advisory Council in the School of Informatics, Computing and Engineering of Indiana University, and Member of the Executive Committee of MCCIA. Anand is a founding member of iSPIRT, India's first product think tank and is a founder member of Inter Institutional Inclusive Innovations Centre (i4C).

Currently, he serves as a Trustee of the VLDB Endowment (www.vldb.org), Trustee of BAIF and as a Trustee of Persistent Foundation. With members of his family, he has established DeAsra Foundation (<http://www.deasra.in>), a non-profit entity which focuses on creating self-employment at scale.

He has been recognized by his alma mater, IIT Kharagpur, as a Distinguished Alumnus in 2012 and by the School of Informatics of Indiana University with the Career Achievement Award in 2007.

Anand received his B. Tech. (Hons.) in Computer Science and Engineering from the Indian Institute of Technology (IIT) Kharagpur. He earned his M.S. and Ph.D. in Computer Science from Indiana University, Bloomington, Indiana, USA.

C. Mechanism

The donor has paid the donation of INR 10,00,000 (Rupees Ten Lakhs only) (Total Donation) to IIT Kharagpur at the time of signing the MoU. The Total Donation, after deducting 10% Overhead Cost, will be utilized to cover the expenses of the award.

The financial assistance will be limited to the following three particulars from the Grant (students are allowed to apply for one, two or all three particulars):

| <u>Particulars</u> | <u>Financial Supports</u> |

| Registration Fee | INR 50,000 or equivalent or actual whichever is less |
| Travel Allowance (to and fro airfare by economy class) | INR 1,50,000/- or actual whichever is less |
| Accommodation and Food charges | INR 20,000/- per day (maximum 5 days) |
| Total | INR 3,00,000/- per student (Maximum) |

D. Eligibility Criteria

- 1) Discipline: UG/PG/MS/PhD female student from the Department of Computer Science and Engineering.
- 2) Students with disciplinary action against him/her or with a backlog will not be eligible for this award.
- 3) At least one faculty member of the Department of Computer Science & Engineering must be a co-author of the paper.
- 4) The student must have done the work presented in the paper while being enrolled as a regular student in the department.
- 5) A student is eligible to apply for the award only once during his/her tenure as a student in the department.

E. Selection Process

The Department will recommend application(s) from the student(s) to the *International Travel Support Committee* of the institute. The committee then will select the student(s) for granting the award as per existing rules of the institute.

F. Reporting

The student receiving the award is expected to send an email to the donor with a brief description of his/her background and a summary of work presented in the conference.

From the second year of donation, the donor will get a statement of utilization of funds till date from the Alumni Office by 31st July each year during the period the fund remains operative.

G. Summary


The travel grant of up to Indian Rupees 3,00,000 (Rupees Three Lakh only) to be given to UG/PG/MS/PhD female student(s) from the Department of Computer Science and Engineering for presenting a paper in any international conference.
