The modalities remain same except the following change:

- (1) For international visitors the honorarium is proposed to USD 200 per day, except USD 100 per day, looking at the stature of the high profile visitors.
- (2) Daily allowance is enhanced to Rs 2500/= (for Track 1) and Rs 1800/= per day (for Track 2) to cover IIT Kgp. guest house charges. (3) Slight enhancement in amount to support international students (Track 4).
