

#### "ITEM:SENATE – 324.F.I.C.6

To consider the proposal submitted by the Dean of International Relations regarding Policy for Admission of Foreign Nationals into Doctoral Programs of IIT Kharagpur.

The Senate at its 322<sup>nd</sup> meeting held on 21<sup>st</sup> September 2017 constituted a committee to frame a revised rules for admission of foreign nationals into Masters and Doctoral programme of the Institute.

The Research Programme Evaluation Committee at its 206th meeting held on 07<sup>th</sup> March 2018 recommended the above for consideration and approval of the Senate.

## Draft policy for admission of foreign nationals into Doctoral Programs of IIT Kharagpur

*Report of the Committee set up by the 322<sup>nd</sup> Senate Meeting on 21.9.17 (322.F.I.C.5)*

### 1. Scope:

This draft policy deals only with doctoral programs. Admission of foreign citizens into postgraduate programs of IIT Kharagpur will be submitted separately.

### 2. History:

Several attempts have been made over the years to address the issue of admission of foreign students into IIT Kharagpur's doctoral program. A brief history follows:

#### 2.1. 2009, Senate item 287.F.I.16.

Joint PhD with foreign universities. The salient points were:

- must have MoU
- every such program must be approved by Senate
- DSC= "Advisory Committee", etc.

#### 2.2. 2012, Senate item 302.F.I.C.7.

Admission of sponsored foreign candidates to PG/PhD programs. The salient points were:

- Tuition fee (\$4000/\$2000)
- min. 2 yrs employment
- min 80% marks or 8.5/10 CGPA in UG (& PG)
- 80/120 in TOEFL, GRE/GMAT/LSAT cutoff to be set by Depts.
- 3 recos
- VC/in-person interview
- NoC from MHRD, MEA
- other Institute rules remain, etc.

#### 2.3. 2015, Senate item 315.F.I.C.4. ✓

Admission of foreign nationals to PhD program under **endowment** scheme. The salient points were:

- how to deal with "Restricted" countries
- \$500 Registration fee
- Tuition fee (\$4000/\$2000) for "self financing" students
- Tuition fee same as Indians for endowment funded students
- min 80% marks or 8.5/10 CGPA in UG & PG (contd.)
- 95/120 in TOEFL, GRE/GMAT/LSAT cutoff to be set by Depts.
- 3 recos
- VC/in-person interview




